Any cancellations or changes to the order must be made in writing. Any cost of parts already bought and labor already performed and then deleted may still be charged at our discretion.

In any calls or correspondence, please refer to the order form number and a description of the job. Please advise immediately of any changes of phone number or address.

We reserve the right to reject unsuitable firearms. Where repairs are necessary, we will make these at our discretion and charge appropriately. Parts, whether custom-made or factory, are supplied and installed on an exchange basis.

Prices and specifications are subject to change without notice. We reserve the right to substitute comparable parts, materials and designs.

While we will make a concerted effort to meet delivery commitments, quoted delivery times are approximate and non-binding.

Loading data and user information is provided where applicable.

Bowen Classic Arms Corporation takes reasonable precautions in the receiving, storage and shipping of customers' firearms. We will not, however, assume any responsibility for the losses of customers' guns through theft, fire or any other circumstances beyond our control.

**PAYMENT**

Balance due at notification of completion at which time an invoice will be sent. Accounts not settled within 30 days of notification will incur a monthly surcharge of 1.5% (18% per annum) on the balance due. Payment by money order or cashier's check; personal checks must clear (2-4 weeks). *NOTE: Tennessee residents must add 9.25% state sales tax on transactions not conducted through a licensed (FFL) dealer.*

**SHIPPING**

Firearms may be shipped between owners and gunsmiths/custom gunmakers, via common carrier, without the services of a Federal Firearms License (FFL) holder (27CFR, part 178.147) Please do not mail guns. UPS is preferred. Firearms are returned UPS unless otherwise arranged. FFL shipping address prevails.

*Please do the following when shipping:*

[1] Enclose the order form, filled out as completely as possible. If your job entails any sort of sight-related modifications, please advise general type of ammunition to be used.

[3] Remove scopes/mounts unless necessary to the work. Expect a surcharge if we have to remove them. Please include a set of grips, preferably factory original style.

[4] For additional security, ship UPS.

[5] Allow \$60.00+ return handling and shipping for most guns. Add \$.90 per \$100.00 of value for insurance. Alaska, Hawaii and International extra, as required.
